

Description of Services

By signing this proposal, dated 17/04/2024, Nysted Camping v/Henrik I Søby, hereinafter "Nysted Camping" becomes entitled to the services described below:

Service for financing climate projects

The service of financing climate projects comprises the procurement and provision of verified emission reductions specified in type and quantity on page 1 of this proposal (hereinafter "amount"). For this service, ClimatePartner supports climate projects that have been verified according to the highest internationally recognised standards.

The following applies to emission reductions via climate projects in the ClimatePartner inventory: The service is provided via the digital management system, the "ClimatePartner Footprint Manager". Once the order has been placed by Nysted Camping, ClimatePartner will book and allocate the entire amount in its "ClimatePartner Footprint Manager" for Nysted Camping.

Each allocated amount in the "ClimatePartner Footprint Manager" is documented in an order overview and can be viewed at any time by Nysted Camping. Furthermore, for each allocated quantity, an identification number (ID) is generated that can be used to track the allocated quantity online ("ClimatePartner ID tracking"). The visitor to the "ClimatePartner ID Tracking" is provided with information on the amount and the supported climate project, including image material (if available).

The amount booked in the "ClimatePartner Footprint Manager" for Nysted Camping will be retired by ClimatePartner within the respective Registry at periodic intervals for the technical documentation of the service provided. In the event of Nysted Camping requiring additional emission reductions beyond the agreed amount, a new agreement will be reached by the contracting parties regarding both the climate projects and the associated fees.

If, for unforeseeable reasons for which ClimatePartner is not responsible, no emission reductions from the listed climate projects are available in sufficient amounts, ClimatePartner is entitled to provide emission reductions from comparable projects at a maximum of the same price.
